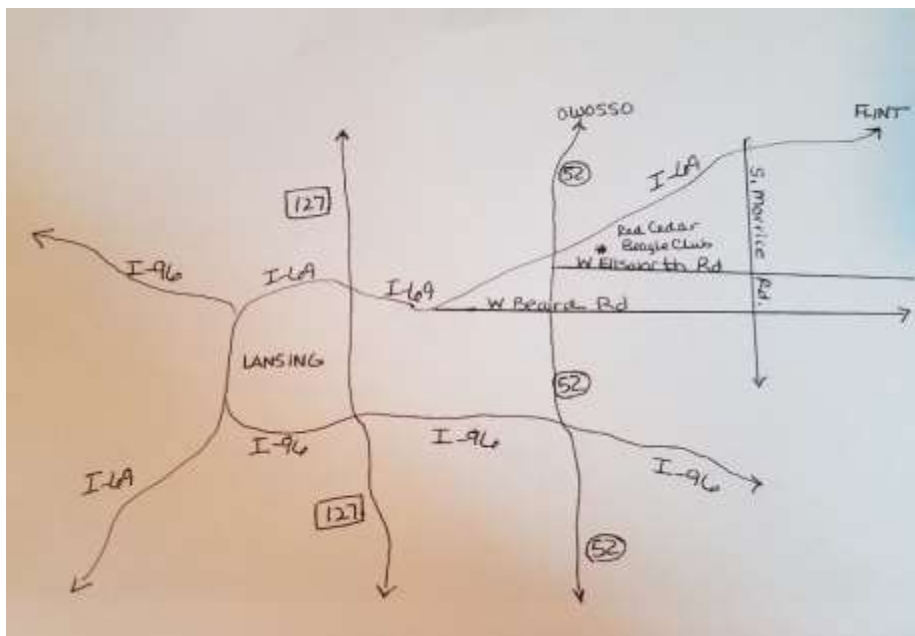


ROSETTES & PRIZES

ADDITIONAL INFORMATION

GROUNDS

The grounds will available for set up after 12:00 noon on Friday, October 16, 2020. Please keep your set-ups clean, pick up after your dogs and do not leave trash (including baggies, water bottles, etc.) in the field trial grounds.

All dogs must be on lead or secure in x-pens / crates except when under judgment during the trial. It is strongly advised that no dogs be left unattended in ex-pens.

PRACTICE

No practice on the grounds will be allowed.

DRESS

It is recommended that sturdy shoes or boots and durable clothing be worn. Bring appropriate gear, as the trial will be run rain or shine.

HARNESSES. The AKC rules are silent regarding the use of body harnesses. As a result, body harnesses will only be allowed if the handler receives advance permission of both judges for the class. If the harness is allowed by the judges, the field trial committee rule is that the harness must be well fitting with nothing hanging from it and with no attachments other than tags for identification purposes and the harness must remain on the dog the entire time the dog is under judgment.

TRACKING COLLARS. The use of tracking collars will not be allowed at these trials.

FOOD. Breakfast and Lunch will be available for purchase at the grounds.

BEATING BRUSH. Everyone needs to contribute to the success of the trials in some way. Beating brush is an essential part of field trialing, and the trial cannot be conducted without brush beaters. Everyone physically capable of beating brush is expected to take their turn.

MOTORIZED VEHICLES. Motorized vehicles will not be allowed in the field.

ENTRIES. Pre-entry will not be accepted for these trials. Entry forms must be complete, legible and submitted on a regulation 5 ½" x 8 ½" form. A separate entry form must be submitted for each dog for each trial entered. Please make checks payable for entry fees to [WDC](#).

The following COVID precautions will be in effect:

- Please do not attend these trials if you have:
 1. a fever, cough or flu-like symptoms;
 2. tested positive for COVID-19 and have not been free of fever without fever suppressing medication for 10 days;
 3. traveled internationally in the past month, unless you are a resident of that country;
 4. been in direct contact with someone with COVID-19 in the past 14 days.
- Hand sanitizer, disinfecting spray or wipes and soap for hand washing will be available in the clubhouse.
- Avoid touching dogs that are not your responsibility.
- Please bring/wear your own mask (disposable or cloth) when social distancing is not possible.
 - Adequate social distancing should be possible in most outdoor situations, such as beating brush, competing with dogs in the field and judging.
 - Masks must be worn in the clubhouse, except while you are eating or drinking.
 - Practice social distancing and avoid congregating to the extent possible.
- Weather permitting, roll call and bracing will be held outside to allow social distancing. Please bring your own pens and pencils. If you take a pencil from the clubhouse, do NOT return it.
- Ribbons and prizes will be available for pick-up (no awards ceremony). Handshaking and physical contact is discouraged.
